*Islamabad, the 11th July, 2007*

**Establishment of the Oversight Board to monitor the implementation of the Export Control on Goods, Technologies, Materials and Equipment related to Nuclear and Biological Weapons and their Delivery Systems Act (Act No. V) 2004.**

**S.R.O. 693(I)/2007.**—Pursuant to section 3.1 (e) of the Export Control on Goods, Technologies, Materials and Equipment related to Nuclear and Biological Weapons and their Delivery Systems Act (Act No.V) 2004, the Prime Minister of Pakistan has been pleased to approve the establishment, with immediate effect, of an Oversight Board, to monitor the implementation of the Act, as under:—

2. **Title.**—The said Board shall be called Oversight Board of Export Control Act No.V of 2004.

3. **Constitution.**—The said Board shall consist of a Chairman and ten members as follows:—

**Chairman**

Secretary, Ministry of Foreign Affairs will be *ex-officio* Chairman of the Board.

**Member/Secretary**

Director General Strategic Export Control Division (SECDIV), Ministry of Foreign Affairs, will be *ex-officio* Member and Secretary of the Board.

**Members**

Additional Secretary (UN&EC), Ministry of Foreign Affairs will be *ex-officio* Member of the Board.

Additional Secretary (CS&M), Cabinet Division will be *ex-officio* Member of the Board.

Additional Secretary (III), Ministry of Defence will be *ex-officio* Member of the Board.

Additional Secretary (I), Ministry of Interior will be *ex-officio* Member of the Board.

Member Exports, Central Board of Revenue will be *ex-officio* Member of the Board.

Director General Security Division, National Command Authority (NCA) will be *ex-officio* Member of the Board.

Director Arms Control and Disarmament Affairs, Strategic Plans Division (SPD) will be *ex-officio* Member of the Board.

Executive Member, Pakistan Nuclear Regulatory Authority (PNRA) will be *ex-officio* Member of the Board.

A Pakistani Expert, with experience in export controls, serving in an honorary capacity with logistic support, to be selected by the Chairman of the Board, will be Member of the Board.

4. **Functions.**—The functions of the Oversight Board will be to monitor the implementation of the Export Control on Goods, Technologies, Materials and Equipment related to Nuclear and Biological Weapons and their Delivery Systems Act (Act No.V) 2004, including the formation and functioning of SECDIV.
